The information provided below is derived specifically from documents provided by our raw material suppliers. The Detmold manufacturing facility is certified under AS/NZ: ISO9001 and BRC classifications.

### **Sustainably Sourced Board**

The paper and board used to make our paper bag and carton products is sourced from 100% sustainable and ethical sources. The Detmold Group uses only paper and board from large, reputable raw material suppliers, which means no old growth forests are used. We keep the use of inks and adhesives to a minimum, and prioritise the use of water-based and soy inks wherever possible as a more environmentally-friendly alternative to solvent-based inks.

### **Paper/paperboard**

Complies with:

Australia New Zealand food standards code 1.4.3 "Articles and Materials in contact with food "USFDA 2010 21CFR Parts 170-199 European Commission Regulation EC/1935/2004, guided by German Bfr Recommendation XXXVI.

### **Adhesives**

Comply with either USFDA 2010 21 Chapter 1 Parts 175.105 and 177.2600, where applicable, or in accordance with Recommendation XXXVI of the Bundesinstitut fur gesundheitlichen Verbraucherschutz und Veterinarinarmedizin (Federal German Institute for Consumer Health Protection and Veterinary Medicine), for use with papers for food contact applications, where applicable.

### **Inks**

When printed, all the inks used are water or soy based and classified as non-hazardous. Good manufacturing practice guidelines are used to ensure adequate barrier properties are intrinsic to the construction of the products whereby the paper is a functional barrier between the ink and the product and the ink is never in direct contact with the product contents at any time.

The finished product is processed under ISO 9001-2015 Quality Management System and BRC Food Packaging Safety Management System.
