Ideally optimum flavour development will be achieved after 12 hours marination under refrigeration. Variation to flavour level will occur with different marination times.
3. Basting Sauce/Glaze - Baste uncooked meat portions prior to and during cooking by grilling, barbecuing or oven roasting.
