- Oates Tilt-a-matic features a unique tilting mechanism that allows easy cleaning of cupboards, beds and hard-to-reach areas like under tables.
- 100% Cellulose sponge refill is highly absorbent and ideal for tiled flooring.
- Scour dot removes stubborn dirt.

### CARE RECOMMENDATIONS

- Rinse sponge thoroughly before use.
- Test that sponge is secure onto mop prior to use.
- Test scourer in an inconspicuous area prior to use.
- Use of chlorine bleach solution will affect the life of the cellulose sponge.
- Recommend regular inspection and storing indoors.

### HOW TO REPLACE REFILL

- For easy removal, rinse sponge under warm water until it is soft.
- To remove refill: Grip one side of the sponge, ensuring your thumbs and fingers are on the plastic sponge plate. Grip the plastic mop frame with your other hand and pull the sponge away from the mop frame. Might require some force to detach. Repeat process on the other side of the mop.
- To attach new refill: Align the plastic pins on the mop refill with the holes in the squeeze mop frame, and push into place.
- To replace scour refill: remove scour pad using your fingers, ensuring excess scour fibers are removed. Align new scour pad and apply firm, even pressure.

Keep palletized products in a cold and dry place. Avoid exposure to direct sunlight. Product is not subject to transportation regulations for hazardous substances or chemicals. Disposal via landfill or incineration possible. Please respect local regulations.
