Fibrous Casing is manufactured by forming a special thin paper made from selected abaca fiber into a continuous tube which is then impregnated with viscose prepared from wood pulp. Fibrous Casing is a smokeable and inedible casing for processed meat and poultry products and smoked cheese.

Structure:	Pure regenerated cellulose	52-72%
	Glycerin	20-24%
	Moisture	4-22%
	Oil	0-2%
	Additives	0-4%

Note: If supplied in pre-shirred form, then the casing also contains an approved proprietary anti-mould agent.

Available sizes: Approximate filled sizes range from a calibre of 38mm to 200mm.

Colours: Fibrous Casings are available in natural and several colours.

Storage: Avoid excessive heat (>95°F/35°C) or temperatures below 39°F (4°C). Humidity loss should be avoided. Keep boxes closed and stored at 70% RH. Fibrous Casings are "Best Before" 12 months from the date of packing.

Instructions: Product should be soaked in water between 30-40°C) for a minimum of 30-60 minutes (pieces) and 60 minutes (shirred material). For sanitary purpose and retention of quality, Fibrous Casing, once soaked, should be used within the same day. The edges of Fibrous Casing should be protected against abrasion and not be allowed to contact hard or rough surfaces directly.

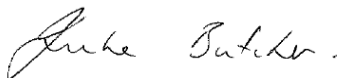
